PARENT CONFERENCES 9.15

The Academy shall develop and implement plans that will provide the opportunity for the parents and/or guardians to schedule conferences with their child's teacher(s). Such plans shall require the Director, after consulting with faculty members, to notify the parents and/or guardians of all students in the Academy that they may schedule conferences with teachers and administrators to discuss educational matters related to their child. Said notification shall be in written form and shall identify the procedure for scheduling a parent/teacher conference.

Parent-teacher conferences must be scheduled at times that will not interfere with the teacher's/teachers' instructional-responsibilities, preferably at the close of the school day or during the preparation period.

ADVERTISING AND PUBLIC SALES

No commercial advertising shall be permitted in school buildings or on school grounds or properties unless approved by the Board. Publications of the School shall not contain commercial advertising. This prohibition shall

Nothing herein shall be construed to prevent advertising in student publications, which are published by student organizations including, but not limited to, school newspapers and annuals.

Solicitation of advertising or use of the School to promote the merit of any product by brand name or trademark shall not be permitted by the Board.

Public sales shall not be held on school property unless prior approval is given by the president or his/her designee, and no student will be allowed to participate in off-campus door-to-door sales activities.
